



. 40 National Societies, of which 15 Case Studies (3 per IFRC region) . 56 Staff Members and 282 Volunteers



## **VOLUNTEERING POLICY OVERVIEW**



"The other challenge of volunteering is that of financial and human resources, I told you that I am alone, so... One person for volunteering at the national level is a bit weak. [...] So funding challenge, human resources challenge. That's it." [Interview, Staff from NS in Africa] "We have translated IFRC Volunteer policy which gave as a frame and inspiration [...] We have developed the Red Cross Volunteering Strategy and Operational Plan taking into consideration and based on some parts of Volunteering policy (e.g. Promotion of volunteers and volunteering, Protection and support)." [Survey answer, Staff from NS in Europe]

## **KEY CHALLENGES RAISED BY PARTICIPANTS**

#### 1. Listening & Decision-making

 Worst-ranked statement by volunteer respondents in the Ideathon Survey involved volunteer participation in decision-making processes at the NS

"In some rare situation yes, like when proposing online activities for all volunteers and things on small scale at centre or volunteer level, but on strategical things, we only know about the decisions." [Survey answer, male youth volunteer from NS in MENA region]

## 2. Youth Engagement

• Youth as both an area of work (e.g. department) and category of volunteer

"The role of young people is very hard to track; they've got a very distinct voice and a very distinct set of expectations that we are not meeting." [Interview, Staff from NS in Asia and Pacific]

"The youth is a lab; an innovation lab for whole National Society." [Interview, Staff from NS in Europe]

## 3. Technology

Over 90% of volunteer respondents in the Study's Survey reported on the use of digital technologies or platforms, but also recognition of challenges/ limitations

"It is sometimes limiting in some communities where access is difficult and should be more interactive."

[Survey answer, male youth volunteer from NS in the Americas]



## **FORWARD-LOOKING TRANSFORMATIONS**

"That is what volunteering is really about, offering your time to do something extraordinary. So I think the challenge we face is that all of the future trends, this Strategy 2030 for the Federation, particularly the transformations, so looking at volunteering, [it] talks about re-imagining and recognising the changing nature of civic action. What is it we need in this future policy at that high level that starts to call this out?"



The IFRC Policy gives an overall framework and definition of volunteering When working with volunteers in the local branches, and with local leaders, it reminds us that we are part of the IFRC and across our global organisation there are lessons to be learnt

#### Why is your NS Volunteering Policy useful to you?

It specifies the volunteering types

The connections between the IFRC and NS policy shows how the policy drives the NS policy framework It reflects details about the volunteer journey in our NS from recruitment until exit

#### How does your policy support your volunteers in the activities they carry out? Are there any challenges?

Policy is key to prioritise safety, security and well-being of volunteers

Existing challenge for some NS is still the lack of insurance to volunteers There can be pressures that stretch and push against the boundaries of a policy in situations of conflict, for example, and this needs to be taken into account

The impact and measurement indicators of the policy could still be strengthened to account for volunteers' activities It is still challenging to understand the roles of a global policy within the diversity of volunteering in the Movement

As a challenge, our NS policy is not always aligned with ongoing development. For example, it does not include online volunteering Protecting the RCRC logo while in the field can be a challenge, to make sure that volunteers only wear the uniform when assisting people only, and not engage in other unrelated activities. Some volunteers will give the uniform to their families to just wear it, without considering the NS Code of Conduct. It is challenging to cover all areas of volunteering in a policy document

For us the challenge can also be that you want to connect globally but also want to be in touch with the volunteer that is working locally. The ideas of the two are not always the same and it is a challenge to make a policy that connects to both
